Memorandum of Agreement

1. The North Central Poultry Association agrees:

- A. To permit the use of the prefix "U.S" in connection the terms used in describing, advertising, and selling poultry and poultry products of various classes of the National Poultry Improvement Plan when the proper quality is attained and when satisfied that the proper compliance has been made to all rules and regulations of the National Poultry Improvement Plan and the North Central Poultry Association.
- B. To direct and supervise work done relative to flock selection in the various breeding stages, testing for Pullorum Typhoid and hatchery operations provided for in the National Poultry Improvement Plan.
- C. To conduct the inspection work called for in the National Poultry Improvement Plan. To report to the Veterinary Services Division of the USDA any member of the poultry industry participating in, but not complying with the auxiliary provisions of the National Poultry Improvement Plan.

2. The breeder, hatcheryman, or dealer agrees:

- A. To comply with the requirements of the above-named phases of the National Poultry Improvement Plan and rules and regulations of the National Plans Division of the North Central Poultry Association.
- B. To keep records called for in the National Poultry Improvement Plan and to make such records available to the North Central Poultry Association.
- C. That before any action is taken or caused to be taken by the participant against the National Plans Division of the North Central Poultry Association or any of its members or employees, the participant agrees to present a written statement of their complaint to the National Plans Division of the North Central Poultry Association within 30 days.

3. Revocation of Agreement

- A. This agreement may be revoked by the North Central Poultry Association for any violation pertaining to the National Poultry Improvement Plan. In case of revocation, the participant agrees to forfeit all fees paid to the Official State Agency. All rights and benefits or participation in the National Poultry Improvement Plan until compliance with the Title 9 CFR can be shown to the Official State Agent.
- B. This agreement may also be revoked by the participant by providing written notice to the North Central Poultry Association.
